Classification Title: Child & Youth Development Specialist

## **Job Summary:**

The Child & Youth Development Specialist provides assessment, treatment and follow-up to children and youth in the community, educational system, and/or hospital setting who are at risk of or with a disability, and/or significant developmental delay. Working with their specific client group and/or their families the Child & Youth Development Specialist plans, initiates, provides and/or supports treatment to further social, emotional, intellectual and physical development.

# Key Responsibilities and Typical Duties:

#### **Core Duties**

- Provides screening, assessment, treatment recommendations, planning, evaluation and follow-up for the child/youth and their family.
- Observes, identifies and reports child developmental or behavior difficulties related to overall development and makes recommendations to appropriate multi-disciplinary team.
- Provides therapeutic treatments including behaviour management.
- Plans/facilitates learning activities designed to enhance the development of the child/youth.
- Creates, implements and updates care plans specific to child/youth needs.
- Assists the family with developing skills to cope with the needs of the child/youth.
- Liaises with and provides referrals to other disciplines and external agencies as appropriate.

## **Other Related Duties**

- Provides information and education regarding child development to parents, education providers, other health care providers and the community as appropriate.
- Supports family funding and education/services placement applications.
- Maintains printed resources and equipment for child and adolescent programs.





#### Leadership

- Orients, supervises and evaluates students, as assigned.
- Provides in-service training and education to educational providers, other health care providers and community service agencies.

# **Decision-Making**

- Determines appropriateness of referrals.
- Evaluates and adapts interventions/activities as appropriate.
- Reviews and evaluates effectiveness of support for the client and family.
- Consults and collaborates with inter-disciplinary professional(s) as appropriate.
- Resolves unusual or complex situations and/or cases or refers the situation/case to the appropriate individual(s).

## Knowledge:

#### Education

 Bachelor's Degree in Child & Youth Care or a related field or equivalent education and experience.

## **Registration Requirements**

Current registration with the appropriate regulatory body if applicable.

# **Working Conditions:**

#### **Physical Demands**

- Required to stand and sit on floor.
- Lifts and carries equipment and supplies.
- Assumes awkward positions.

#### **Work Environment**

- Community or home visits will have variable conditions.
- Travel in all-weather/road conditions.
- May be subject to verbally and/or physically aggressive clients and family.
